The President's Report

Brothers and Sisters.

2023 is upon us! I hope everyone had a great holiday and had a chance to unwind and spend some time with family and friends. It is always good to get a recharge and start the new year fresh.

This year will be a busy year on many fronts. In January you will start receiving ballots for the runoff election for the International President and the Vice President. Ray Curry and Shawn Fain will be in the runoff for President and Chuck Browning and Tim Bressler will be in a runoff for Vice President. Your ballot must be received by February 28, 2023. With the election that concluded in December we now have a new Region 2B Director, David Green, also two new Vice Presidents, Rich Boyer and Mike Booth and a new Secretary of Treasure Margret Mock. I wish all of them luck in their new roles.

This May we will have our general election for all offices within our Local. In September, the contract expires for our Local and International contracts. Local contract proposals will come out in the first quarter of 2023 and the Bargaining Committee will start preparing for negotiations midsummer. This set of negotiations at the Local and International level will be the most pivotal contracts negotiated due to the extreme change in the auto industry that is affecting us, especially locally.

The volumes for the 8-speed look strong for 2023 in the 450k-500k range. The 9-speed volumes are all over the place from 400k-620k for 2023, and with Belvedere

being idled in late February that will affect our volume for the 9-speed. SIEVT volume will be dependent on how much up time Windsor Assembly has in 2023. RFE volume will stay steady in 2023. The volume at the Kokomo Engine Plant will be at capacity or above through 2023 with bringing on two more assembly plants to supply engines as well.

I cannot stress enough that everyone should put some money back just in case the worst-case scenario should happen. I encourage everyone to attend your monthly union meetings so you can keep informed throughout this busy year!

On January 16, 2023, we will have a holiday to remember the Great Leader Martin Luther King Jr. There are 2 quotes from Dr. King that have always had a special meaning to me and those are;

"Our lives begin to end the day we become silent about things that matter. The ultimate measure of a man is not where he stands in moments of comfort and con-


All members are welcome to join our committee, you do not have to be a veteran. We meet the second Sunday of the month at the Local 685 Union Hall at 1:30pm.

Third Place





What is EAP?

EAP stands for Employee Assistance Program. This is anything that affects your ability to do your job that is not the job itself. This includes mental health, addiction, family problems, and

any other life stressors that have a negative effect on your ability to come to work or be productive while you are at work. We even have veteran specific programs. EAP is for you, and it is also available to any of your family members that are covered on your insurance. THIS IS ALL CONFIDENTIAL. We are union appointed representatives and we work as a team with stewards and committeeman in the plant. We do meet with Human Resources and Medical on a case-by-case basis, but only in ways to help you maintain employment.

How does the program work? EAP is voluntary participation only. You can come directly to your representative in person or by phone. Depending on the level of care that is needed, this may be a simple interaction where you get the name and number of a provider to contact. For higher levels of care, your rep may contact a facility coordinator on your behalf. We are a free specialized resource available to you for these specific situations. We will make sure that the services are covered by insurance, and we will work together with everyone involved to get you the best possible care for your unique needs.

What is our coverage? Beacon Health covers our mental health and substance disorder insurance. Anthem Blue Cross Blue Shield is our medical. Oftentimes, facilities utilize both medical and mental health insurance if you have an extended stay. Always make sure the provider takes our insurance.

What is my goal as your EAP Rep? My goal is to provide you with empathetic assistance during life's circumstances. This means treating everyone with respect, kindness, and understanding with whatever it is that brought you to me. Whether it's a history of drugs, childhood trauma that still haunts you today, you got arrested, your family member passed away, or whatever it is that you need to talk about. We will sit down together and assess the situation, then you will decide which steps you want to take from there. I'm here to help and offer up solutions, but it's up to you to do the work. I want you to feel good enough to actively participate in activities both inside and outside of work.

How do you contact EAP in the event of a crisis? Be sure to contact the representative at your plant location. We do not have access to files from the other plants, so it is in your best interest to make sure your representative has the best possible chance to help you with your unique situation.




DEP ExamDisability Evaluation Physical Exam
