Linda was instrumental in the launch and sustainment of the recycling program at KTP. Linda's final job at FCA was UAW Tuition Assistance Program Representative at the Indiana Transmission Plant. Linda is, and I have suspect always has been, driven in the work she does. She is tireless. When you work with Linda she is normally a step ahead of you. She is one of those people that never quits till she accomplishes a goal she has set for herself.

It is those qualities that have made her a great employee and a great editor for the newsletter. On the flip side, Linda has a heart of gold that keeps her very involved with charitable endeavors. She is always happy to work in the background and do the tasks that others do not want to do. She is the type person that is needed in any organization to make sure the work gets done. ## The President's Report

The last couple of months have shown just how fickle the auto industry is. One week it looks like a merger with Renault was all but done, then next week no deal. From what information I could get, it appears that the political conditions in France do not currently exist for a merger. Also, Renaults CGT union was against the merger and had the same number one fear all unions have, job loss. I cannot tell you today if it's a done deal or not.

We should not forget that Sergio Marchionne was seeking mergers with other automakers believing that it was necessary for the company to have a partner in research and development on a global scale. Whatever the case, we need to prepare for the future wave of electric vehicles. Like them or not, they are coming and right now we are behind the eight ball. Our Skilled Trades Committee received a lot of information on what's coming up in the future at the UAW National Skilled Trades Conference. Please read Chris Steward's article in this newsletter about the conference.

As the economy softens, the auto industry is feeling the effects. FCA sold 498,400 vehicles, down 19,000 compared to the first quarter of last year. The largest drops in sales were the Chrysler brand and Jeep. The Fiat brand was the worst, dropping almost 50 percent. That being said the Jeep, Ram, and Dodge were among the best six selling brands across the nation for the first quarter of 2019. FCA did achieve three records in May, led by Ram brand with its 12th consecutive monthly sales record. Both heavy and light duty truck sales remain strong. It was the best May for the Jeep Grand Cherokee. The Dodge Charger had the best May in six years with overall sales rising 2 percent selling 218,702 vehicles.

In its first full month on sale, the all new Jeep Gladiator pickup truck delivered more than 2,500 vehicle sales. Ram truck sales were up 33 percent.

As you all know, we are preparing for local and national negotiations. It's a given that there will be periods of time when you will be frustrated from the lack of information. Negotiations are the heartbeat of the union and to prematurely put out information at any level could cause a loss in bargaining power. On the other hand, the company has no problem putting out pure bullshit to get the membership stirred up hoping that you will lose faith in your union. We, the members, of the UAW are the strength of our great union. We joined the union to have a better life for ourselves and our families. It doesn't stop there, we make communities stronger and safer. We lead this nation in every struggle. No matter your race, gender, religion, or sexual orientation, the union is all inclusive and our diversity is our strength.

For the past 70 years what happened at the UAW bargaining table has directly tied to America's middle class. In the 1940s, under the leadership of the legendary Walter Reuther, they won concessions that are now considered middle-class entitlements. In 1947, the UAW won the first paid holidays for GM workers. In 1949 to avoid a strike, Ford agreed to pay 20 million dollars to pay the entire cost for pensions for workers with 30 years of service. These workers received \$100 a month. This was the first employer paid and jointly administered pension program and later adding fully paid hospitalization, surgical and medical insurance for retirees in 1964. After Reuther's success with Ford, the UAW focused on Chrysler. The company was willing to match the \$100 a month

pension plan, but refused to fund it fully. Chrysler gave in after a long strike of 104 days and losing one



billion in sales. In 1945, after the war, the first negotiations began with Chrysler and they agreed to a wage increase from 18 to 18.5 cents an hour. These are just a few events that have advanced us to where we are today. These actions are known as "Reuther's Treaty of Detroit".

Times are changing and progress is coming fast. When the automobile came to be, there was much skepticism going from the horse and buggy to the horseless carriage. Today, we have cars that have gas engines with automatic transmissions and axles. Now comes the future with driverless electric cars. I wish I could tell how soon this will happen, but I cannot even guess. I do believe that we will continue to build the best transmissions in the world built by the best transmission builders in the world. I ask you to believe in your union, your leadership, and most of all you, our membership. Thank you again for allowing me to be your president.



## **Local 685 Steward News UAW National Skilled Trades Conference**



I would like to thank all of our Local 685 skilled trade members for the opportunity to be one

of your skilled trade delegates. I thank you for allowing me to attend the 2019 National Skilled Trades Conference. It has been years since we have had a National Skilled Trades Conference. International UAW President Gary Jones made a commitment to have a conference every two years so that the skilled trades will have a voice on contract resolutions and a voice in our 2019 contract negotiations.

The first item that was discussed was the allegations of corruption that took place within NTC. UAW International has implemented processes to ensure that this type of behavior doesn't happen again.

The conference proceeded with a report on the strike fund. By July 2020, the strike fund should reach the cap of \$850 million and at that time the extra half hour dues would go away until the strike fund depletes to \$650 million.

**UAW Vice President Cindy Estrada** talked about Industry 4.0 technology. She reviewed this upcoming automation and data exchange in manufacturing technologies and stated that the Skilled Trades Department must and will fight to negotiate for enhanced training in order to prepare for the new technology. She talked about the electronic vehicles which are coming full steam ahead to the "big three" manufacturers and about newer companies, like Rivian who are building the first electric truck in partnership with Ford. GM is possibly joining with Tesla on a new electric truck and FCA may join with Waymo or possibly PSA. Cindy talked about how our collective bargaining has begun to change to

include newer technology. The UAW has to secure new work in order to keep union jobs in America.

Currently, the batteries are the main component for the electric vehicles and 88 percent of the batteries are built in Korea, China, and Japan. This has to change at the bargaining table. As ICE (internal combustion engines) are replaced by EVs (electronic vehicles) 35,000 plus UAW members are at risk. Automakers are slated to invest \$300 billion for EVs production globally. Electrification and automation will impact other industry sectors like IPS (international parts suppliers), Aerospace, Agriculture, Construction, Mining, and Heavy Trucks. There are 13 EV models now and a plan to expand to 91 by 2029.

There was much discussion on 3D Printing about how that will affect us in the very near future. Plants are already introducing 3D printers for tooling. GM plans to have a printer in every plant. Boeing is already using these printers for plane props reducing production hours to 1 hour from the conventional 18 hours. These 3D printers are already making titanium monoblock brake calipers. We will use our strength at the bargaining table to ensure that when a new launch takes place that any new technology comes to our plants. We will stand strong in securing that work and to ensure efficient training on the new technology.

Skilled Trade's wages, in general, were brought up. We are especially lacking in pay in comparison to other unions. We have to get tougher on the full utilization language for skilled trades this contract as well. This needs to be addressed at the bargaining table along with all non-skilled, in-progression workers having the same benefits and pension plans.

There was discussion to great lengths on the Apprenticeship Program. They worked closely with the UAW-LETC to develop a grant submission for \$5 million that was awarded in 2015 that will assist our UAW represented facilities and are currently asking for additional grant dollars. The UAW Skilled Trades Department will fight hard to add as many apprenticeships as possible and will target minorities such as women, US Military Veterans, and others from what are considered disadvantaged populations. In the US, 52 percent of employers cite difficulty in finding and recruiting skilled trades personnel. There is a shortage of skilled trades in the US and 52 percent of the skilled trades' workforce is age 45 or older. In four to five years, there will be around 31 percent of the skilled trades' workforce retiring. UAW Skilled Trades Department has promised to keep fighting for the classifications to stay intact. FCA is utilizing seniority to pick apprentices once they have passed and completed their classes and the application process. In our labor market, there will be around 51 to 52 apprentices added starting around July or August. As always, stand strong in solidarity and we will have more information after the 2019 contract negotiations!






## **PEL Class Overview**


