For the year 2019 sales fell 1.4 percent which equals 2.2 million units. These numbers include the 2.3 percent decline for the 4th guarter. Ram was the only FCA brand with a sales gain in 2019 and in the last guarter posting gains in both periods selling 703,023 trucks. The Jeep Wrangler had the best quarter ever while selling 52,012 units resulting in total sales of 96.935 units at a 21 percent increase. The Cherokee had a record year selling 242,969 units. The Gladiator finished the year selling 40,047 trucks since launching in May, but overall, the Jeep brand was down 2.4 percent. Ram was up 5.5 percent, Chrysler brand down 15 percent, Dodge down 9 percent, and Fiat down 49 percent.

I am being asked what's going on the Peugeot merger. I have received nothing to date; it is said to be a 50-50 merger. I will hold my comments on that until we have heard the equals have merged to a company that alleges to create the 4th largest automaker by sales. It is an expected savings of 4.1 billion dollars without any plant closings. This merger, according to some experts, anticipates that it would create an electric vehicle powerhouse under the leadership of Carlos Tavares who is likened to Sergio and lacocca. We will just have to wait and see.

Your Bargaining Committee is committed to getting back to the

negotiating table to resolve our Local contract. Our trades' leadership is busting their butts to get as much work that is out there as well. Some things will hopefully lead to more apprentices for us. Our tradesmen are showing some age and we need their knowledge and expertise. We need more apprentices so the company doesn't outsource our work.

The National CAP Conference was full of information as always. One of the issues that caught my eye was today here in America union membership is down to 11 percent. The right for workers to come together and collectively bargain with their employer is an internationally recognized human right protected by the First Amendment of the U.S. Constitution and enshrined in U.S. law by the National Labor Relations Act over eight years ago. There is no secret of what the issue is. We need a stronger middle class! A middle class that can purchase high dollar items like homes and union-made American cars. A middle class that can provide their children with an education, so they can continue to have a strong middle class forever. This dream will always be "just a dream" if America's unions remain stagnant.

The gap between the poor and the wealthy continues to grow. The wealthy continue to hoard their wealth, not earned wealth, but wealth earned by the working poor and America's middle class. There are more workers than gazillionaires. With an increase in unionized workplaces, the stronger the



country's economy will be. The rich would continue being rich, but it doesn't take a rocket scientist to figure out that the more workers earn, the more workers spend.

We as a union must step up and let friends, family, all workers know how much better their lives would be if they belonged to a union. There are plenty of reasons to join a union. I know we have our problems in the UAW and I believe these issues are being addressed. The crooks are not what this great union is about. We have plenty to do to fix the wrongs done to the working masses of this great nation. We need to help all workers to achieve living wages, create a mass of homeowners (not renters), ensure all children should be able to eat before and after school, make sure teachers make a wage they can live on and much more. As always, thank you for allowing me to be your President.

According to Wikipedia and Solidarity Magazine, the American

Federation of Labor was formed in 1886 after being disaffected from the Knights of Labor, an International Union of Craftsmen. Samuel Gompers was elected president at the first meeting and remained its president except for one year, until his death in 1924. It became the largest labor union in America during the first half of the twentieth century.

In 1935, from auto plants all over the United States, 200 delegates gathered in Detroit, Michigan to form the first-ever convention of the United Autoworkers of America. There had been heated debate within the American Federation of Labor, the origins of the CIO, for and against the admission of nonskilled workers. The AFL represented mostly artisans and craftsmen. John Lewis from the United Mine Workers of America felt strongly that industrial laborers should be included, so he formed the Committee for the Industrial Organization in 1935. Continued strife caused the CIO to separate from the AFL; they stayed separate until 1955.

In 1936, the second convention of the UAW was attended by Walter Reuther, who returned to the west side of Detroit

to become president of Local 174. It was here with the help of his brothers that he led the first successful strike against automotive company Kelsey Hayes. They were the supplier of brake drums and wheels to Ford Motor Company. December 1936 in protest against the lines speed being increased to dangerous levels, the workers sat down refusing to work or to leave. When management came to remove the machinery, thousands of sympathizers blocked their way. Ford Motor Company needed the parts, so Kelsey Hayes agreed to recognize Walter Reuther to negotiate on behalf of the workers for the UAW. This success caused a dramatic increase in UAW membership.

During this time Walter's brother, Roy, had been trying to organize the GM workers at the Flint, Michigan Plant and a sit-down strike was called to force recognition of the UAW's right to negotiate, with Walter Reuther as the representative. The company responded by shutting off the heat. In solidarity, plants throughout America also went on strike and after 44 days General Motors signed its first collective bargaining contract recognizing the UAW as the workers' representative. In March of 1937, 60,000 Chrysler workers went on strike. The police showed up to rough them up, Walter Reuther led 150,000

citizens in a protest against the police action. Chrysler signed its first collective bargaining contract four weeks later.

Henry Ford stated he would never allow his workers to unionize and hired 3,000 security guards to intimidate employees with beatings or immediate dismissal if any union discussion occurred. Walter got permission from the city of Dearborn to pass flyers out stating simply "Unionism not Fordism". Ford reacted predictably and sent his enforcers to attack. This became known as the Battle of the Overpass and due to the brutality of the attacks guickly turned the public sentiment against him. Henry finally conceded and four years later signed Ford's first collective bargaining agreement with the UAW.

Walter Reuther became president of the International Union in 1946 after his successful organizing of the Big Three. He was an innovative and progressive leader and leveraged the resources of the UAW in support of equal pay for women. He was a strong ally to Martin Luther King, Jr rallying with him in his fight for justice and equality. He supported Cesar Chaves in his fight for the farmworkers' rights. His innovative and progressive thinking put the UAW firmly on the side of fairness and equality for all American workers. In Solidarity!





### National UAW CAP 2020

Mike Rankert Local 685 Retiree Chapter Vice-Chair

Thank you to Local 685 and our Retiree Chapter for giving me the opportunity to attend the 2020 National CAP Conference in Washington, DC.

We spent Monday learning about the bills in congress that will have an impact on labor rights and organizing. We also practiced how we were going to communicate with our congressional

representatives when we went to Capitol Hill on Tuesday.

The main bill we learned about is the PRO Act (Protect the Right to Organize Act) which was going to be voted on in the House on Thursday after we spoke with our representatives on Tuesday. This bill amends the National Labor Relations Act and related labor laws to extend protections to union workers. Specifically, it:

- revises the definition of "employee" and "supervisor" to prevent employers from classifying employees as exempt from labor law protections
- expands unfair labor practices to include prohibitions against replacement of or discrimination against workers who participate in strikes
- makes it an unfair labor practice to require or coerce employees to attend employer meetings designed to discourage union membership
- permits workers to participate in collective or class action litigation

- allows injunctions against employers engaging in unfair labor practices involving discharge or serious economic harm to an employee
- expands penalties for labor law violations, including interference with the National Labor Relations Board or causing serious economic harm to an employee
- allows any person to bring a civil action for harm caused by labor law violations or unfair labor practices.

On Tuesday, my assigned group went to Capitol Hill to meet with Congressman Pete Visclosky from Indiana's 1<sup>st</sup> District. We were led by Local 685 President Rick Ward. Congressman Visclosky was out of town, so we met with his staff member Megan Adamczewski. President Ward asked about the Congressman's position on the PRO Act. Megan said that the Congressman was in favor of the bill and would vote for it. President Ward discussed other bills and also talked about the push for electric vehicles and the effect that would have on our transmission production. He asked if Congressman Wisclosky is in favor of helping us to get future electric vehicle parts into our plants. Megan said the Congressman will do everything he can to help protect our jobs.

Wednesday opened up with a Women's Breakfast hosted by UAW Vice President Cindy Estrada. Representative Debbie Dingell from Michigan, the wife of deceased Congressman John Dingell, was the guest speaker. Debbie is a strong supporter of labor as was her late husband. Representative Dingell spoke of the importance of protecting Social Security and Medicare. She said that President Trump is using the word "socialism" to stir up fear as he tries to cut these important programs. Later Wednesday, we heard from several pro-union congressmen. Senator Sherrod Brown of Ohio said, "If you love your country, you fight like hell for the people who make it work."

Speaker of the House Nancy Pelosi said the House would pass the PRO Act on Thursday which will hold employers accountable for violating workers' rights. She said, "The upcoming election is critical for unions and the labor movement. Republicans are committed to undermining collective bargaining."

The National UAW CAP Conference was held in Washington, DC

from February 2-5. All of the UAW CAP delegates had an opportunity to go down to the Capital Building to lobby Congress on issues that are important to collective bargaining, job security, outsourcing, and most important, the PRO Act, H.R. 2474. This is one of the most significant pieces of labor legislation to come before Congress in years. The PRO Act would make it substantially easier for workers to form and join a union.

There were several speakers who spoke about the upcoming presidential election including Sherrod C. Brown, Senator of Ohio who is very labor-friendly and very supportive of the UAW. Also, Tim Ryan who is a U.S. Representative, Ohio's 13th Congressional District spoke on organizing and collective bargaining along with supporting the middle class of America. Debbie Dingle, U.S. Representative, Michigan's 12<sup>th</sup> Congressional District, was a very motivational speaker as well. Abby Finkenauer, 1st Congressional District of Iowa spoke on family values and how she was raised in Iowa by her father who was a union activist. She was very supportive of the UAW

and organizing to keep the middle class growing. Also, Nancy Pelosi, Speaker of the House, was the last speaker who spoke about the upcoming presidential election and how important it was for everyone to get out and vote.

Our team went to the State Capital to speak to Peter Visclosky, U.S. Representative. We talked about the



PRO Act, outsourcing in America, and affordable health care. Rick Ward addressed new work needed in Indiana for the electrification vehicle that is coming. We focused on which representatives are cosponsors to the issues that are important to the UAW and our wellbeing.

Also, on the Local 685 side of it, our profit sharing was announced recently and the average profit sharing is \$7,250. This is pretty good considering, we progressed through our National Agreement with significant gains on bonuses and raises. Here at Indiana Transmission Plant II, we are making headway with the demolition and are on target to have everything out by June 2020. Looks like there will be construction starting as early as March or April on extending the building out on the south and west side of the plant. We are fighting to retain as much work as possible on the demo and installation part of it.

Our Bargaining Committee is at the table now negotiating our Local Agreement and then negotiating the new launch agreement for the new engine plant. There will be a groundbreaking ceremony in early March with the Governor, CEO Mike Manley, and the International UAW. I am excited to see an engine plant coming to Kokomo, and the opportunity to show FCA that our members of Local 685 in Kokomo will succeed in launching the new product flawlessly. It is very important that we get a successful launch and start up. This will only prove that we, Local 685, have what it takes to build anything they bring here into nothing less than the very best top-notch engines and transmissions.


